## RESTRUCTURING IN CONTEXT

The concepts of Insolvency, Corporate Rescue, and Business Recovery have all become familiar to both financiers and businesses in Cyprus in recent times. Ongoing trading and economic difficulties, or even isolated events, can result in a situation where a business is unable to meet its cashflow and debt repayment obligations and/or its liabilities exceed its assets.
